Cllr Falconer reported on a complaint about the Inspector's report from the Watermill Bridge which appears to have been written before the Appeal as some of the factual statements are incorrect. Further information will be obtained by Cllr Falconer from the DC meeting at BDBC on 07 February 2024.

It was agreed to investigate whether HPC could employ an arborculturist to check the health of all TPO trees in Penwood Heights in one go.

Action: Clerk to obtain a quote from arborculturist for tree inspections in Penwood Heights.

Local Plan Update Consultation: to agree a response: All councillors were encouraged to respond as individuals.

10. 91/23 Neighbourhood Plan update- effect of Wash Water 21/03394/OUT appeal decision

The NP team is now considering how to move forward with the NP since the Appeal decision. It was decided a meeting is needed with planning policy officers at BDBC. Colin Wall will pursue this, along with an urgent discussion with Planet.

11. 92/23 Lengthsman- next visit 22nd February 2024

Jobs to be completed- digging the trench at Mount Road again; all road signs in Highclere and Penwood.

12. 93/23 Trees- completion of work at Highclere Village Hall

The Clerk confirmed a tree has been felled next to Highclere Village Hall by Highclere Tree Works; the council and HVH committee is satisfied with the job.

13. 94/23 Penwood- Option to purchase defibrillator with a grant, and request for a bench at Woodlands Stores

The Clerk has applied for a grant from London Hearts, supported by the government, to install a defibrillator at Woodlands Stores, Penwood; the cost to HPC is £750. Full council agreed to the purchase and the Clerk will arrange installation (the agreement with London Hearts is that the defib is installed within one month of receipt of defib).

The Clerk has also received a request to reinstall a bench at Woodlands Stores. The Clerk has sent information on suitable benches to the Stores and will continue the discussion. Full council agreed in principal for a bench. The Clerk suggested the one which was purchased at site on the A343 would be suitable: <u>https://uk.glasdon.com/lowther-seat</u>. Clerk will continue to discuss options with Woodlands Stores.

14. 95/23 Westridge Project Update

Cllr York has received a quote for the improvement of the Star Lane entrance. Other activities planned: Rotten gate posts will be removed and replaced with a gate on the Andover Road. A hedge will be planted to replace the chain link fence, shrubs will be dug out to open up the garden, lawn tidied, trees planted and staked, plus benches. A shared prosperity grant will be applied for to improve the car park, to include disabled parking.
