The Chairman, Brad Norton welcomed everyone to the meeting.

**1. 94/21 Apologies for Absence**

**5. 98/21 Public Participation**

No one from the public was in attendance.

**6. 99/21 Reports from County and Borough Councillors**

**Cllr Falconer** sent an update to the PC regarding planning applications: the Policy Planning Team have put in a consultee report on Watermill Bridge, arguing that the flood plain issue is too significant for it to be approved.

**Cllr Thacker:** reminded us about his County Councillor grant; the council will ask for a grant towards replacing the bench that has recently been removed opposite the Red House pub on the A343.

**Action:** Clerk to apply for grant for a new bench.

The information on the bollards along the A343 before Seven Stones Bridge was disputed in Cllr Thacker's report- the bollards are due to be removed by Highways in the New Year. The Council argued that the reason why the bollards are there is not just for preventing parking, but also because wild orchids grow there. There is a sign there to request no strimming because of these orchids. Cllr Thacker will report this back to highways who are likely unaware of this.

Highways will straighten any wonky poles if the removal of bollards is carried out.

**7. 100/21 AONB- feedback from virtual meeting**

Cllr York gave feedback on the meeting with the AONB. What was striking was the lack of awareness of what they do as an organisation. It was thought that signage in the Parish may help with recognition of the importance of being in the AONB.

**The SID likely needs repair;** it is losing too much battery power and settings at each location move. Cllr Easton will send it back in the New Year.

**12. 105/21 Environment**

**Taking Pride in Highclere:** Cllr Smith brought samples of the footpath signs for Highclere. Cllrs Dierks and Smith will decide which ones to use and place them on one footpath as a trial. If positive feedback is received, then more permanent signs will be investigated.

**13. 106/21 Website update- improvements and data**

The Clerk briefly explained the improvements made to the site; the news and planning are now more prominent, following statistics provided by Silver Linings Consultancy that the majority of users view these pages.

**Data from new site:**

- Sessions 222, Unique visitors 123
- Average time on site per visit: 4m 10secs (4mins is a benchmark set by Google for good performance)
- Most traffic is coming directly to the site or through Google although there are decent numbers from Facebook showing the posts there are working.
- These numbers are pretty good given the size of the audience we are aiming at and are an improvement on the original site.
- Most visitors to the site are from the UK although there is traffic from Germany, the USA and Canada.

## **Neighbourhood Plan Update, Colin Wall**

Two meetings have been held on Nov 16<sup>th</sup> and Dec 7<sup>th</sup>, the latter by Zoom as a concession to the latest Covid developments.

### *Community Survey*

Final copy should be complete this month. I will send it to the Clerk for publishing.

Some additional analysis has been done by David Skyrme which should be available for publication after our January meeting.

### *Project Plan*

A revised version of the Project Schedule was agreed after consultation with PlanET. The current prospective date for the Referendum is now May 2023.

### *Next Steps*

There has been substantive discussion about whether now is a good time to issue the Call for Sites, given the recent emergence of the Watermill Bridge application and the immediate and vocal public opposition to it. Although cogent arguments on both sides were presented, there was unanimous agreement that delay would have a negative impact on how quickly our own views could then gain statutory weight, and we should therefore press ahead.

The Call for Sites is planned for issuance this month along with an application for (even) more grant-funding for the subsequent Site Assessment. The issuance will be presaged by the publication of a short introductory article on why we are still going ahead in the context of recent applications.

It was further decided at the December meeting that the NPSG will submit an objection to the Watermill Bridge application, but based purely on NP considerations.

## **Hampshire County Councillor update**

### **December 2021**

#### **Community Climate grants**

The Council is inviting bids for grants to make community buildings more energy efficient as part of its commitment to combatting climate change. These grants are provided under the Parish and Town Council Investment Fund.

**Capital** projects that could be funded include solar panels, LED lighting, window replacements or insulation for buildings such as village halls and community centres.

**Revenue** grants for measures that meet local needs are also available with an upper limit of £30,000. Schemes that enable local communities to be more resilient, for example encouraging 'neighbourliness' and tackling social isolation or for the management of community assets could be eligible.

**Training** investments up to £10,000 to provide appropriate training in the local community. This could cover a broad range of schemes, for example training from specialist skills for Parish Clerk through to local path wardens looking after their rights of way.

### **Community Waste Reduction**

Grants of up to £5000 are available for community organisations. Grant funding is available to community groups, small businesses, schools, charities, and parish councils to fund projects that will introduce a new waste prevention, reuse or repair project to the local area.

### **Christmas Holiday Grant**

Hampshire County Council will offer healthy food and activities to children who are eligible for free school meals during the Christmas holidays. Parents and carers can sign up for free school meals using the [Hampshire Online FSM Application \(cloudforedu.org.uk\)](https://cloudforedu.org.uk) and find out what local activities are on offer by searching the [Family Information and Services Hub](#).

County Council Leader, Councillor Keith Mans has written to Hampshire's MPs to seek their support for a more equitable funding solution. Rural councils like Hampshire have historically received lower funding from central Government than the metropolitan authorities. Although major funding reform at the current time is difficult, a change is needed in the short term otherwise those authorities at the bottom end of the funding tables will continue to be hit the hardest as we recover from the pandemic.

### **Local matters**

I have also written to Councillor Mans, Councillor Rob Humby and Rt Hon Kit Malthouse, MP asking that local and national government work together to find a national solution to the issue of cross-border access to household waste and recycling centres, without having to be charged on top of their Council Tax. Kit has replied, saying that he is raising the matter with the minister. Cllr Humby has also replied, explaining the financial strains the County faces.

The Local Highway Engineer has looked at the bollards on the A343 and whilst agreeing that they do make this section of the A343 look untidy, deems that there isn't anything reported that is a safety issue. Therefore, at present there are no plans to carry out any immediate work here.

Highways has confirmed with HCC Traffic Management that the bollards/verge marker posts are no longer required on the bends as the speed limit has been changed in recent years. Therefore, he proposes in the new financial year to have posts removed completely. This will help make the verge maintenance/grass easier.

At the same time Highways will arrange for any leaning signs to be straightened and cleaned and have a general tidy up.
